## **TERMS AND CONDITIONS OF ELIGIBILITY:**

These terms and conditions apply to the elections for the Management Committee of Te Roopu Raranga Whatu o Aotearoa ('TRRWoA').

### **Eligibility to vote:**

- 1.1. All financial members\* of TRRWoA are eligible to vote in the biennial election.

### **Eligibility of nominees:**

- 2.1. All nominees must be financial members of TRRWoA.
- 2.2. TRRWoA exists to preserve the art form and traditions of weaving in Maori culture. It is with this central aim in mind, that the Management Committee of TRRWoA reserve the right to void nominations that they feel do not either fulfil these aims or help to continually develop the art form and its practices.

### **3. Nomination process:**

- 2.1. The date of the election will be determined by the current Management Committee of TRRWoA.
- 2.2. Nominations will be received by proposed nomination form sent out by the Returning Officer of Te Roopu Raranga Whatu o Aotearoa.
- 2.3. The nomination form is to be signed by 'The Nominator' and signed by a Seconder' and also 'The Nominee'.
- 2.4. All 'Nominees' must be financial members of TRRWoA.
- 2.5. All 'Nominators' must be financial members of TRRWoA.
- 2.6. All 'Seconders' must be financial members of TRRWoA.
- 2.7. The deadline for nomination papers will be proposed by the Management Committee of TRRWoA.
- 2.8. No nominations will be received after the deadline. Nominations should be sent to reach the Returning Officer before or on the set deadline.

\* Financial members are those who have paid the \$120 subscription fee for the two year period preceding the biennial election.
